The board grades are in compliance with the rules of the

Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), establishing a European Chemicals Agency, Official Journal of the European Union L 396 of 30 December 2006, last modified by Commission Regulation (EU) No 2021/1297 of 4 August 2021, Official Journal of the European Union L 282/29 of 5 August 2021, Annex XVII Nos. 51 and 52,

and of the

regarding the content of phthalates.

As far as the content of heavy metals is concerned, the board grades meet the demands of the

Directive 94/62/EC of the European Parliament and of the Council of 20 December 1994, on packaging and packaging waste, Official Journal of the European Communities L 365/10 of 31 December 1994, last amendment by the Directive (EU) 2018/852 of the European Parliament and of the Council of 30 May 2018, Official Journal of the European Union L 150/141 of 14 June 2018.

Thus the board grades **Eskaboard**, **Eskaboard Thin** and **Greyliner** according to the sample material submitted may be used safely for the production of books, files, binders, game boards and puzzles, as long as they are intended for children older than 36 months. Furthermore, they may be used in displays and luxury packaging.

Moreover the board grades may be safely used in the field of food packaging. They may stand in direct contact with foodstuffs which are peeled, shelled or washed before consumption. The employment as secondary packaging can be achieved by using an appropriate intermediate packaging.

This certificate of compliance has a validity of 2 years and consists of 5 pages.
